

Conditions and terms of participation

Participation in the competition of VS Medien GmbH, Bad Ems, hereinafter referred to as the operator or organizer, is free of charge and is governed exclusively by these conditions of participation.

Procedure of the competition

The duration of the competition is from March 9, 2020 to midnight May 31, 2020 (12:00 am/24:00 hrs). Within this period participants will be given the opportunity to participate in the competition.

Participation

In order to participate in the competition, a "GLOCK experience" in the form of a photo using a GLOCK firearm and a "GLOCK target" (<https://eu.glock.com/en/g44target>) must be posted on one of our social media channels on Facebook or Instagram. An alternative participation due to shooting range closures due to Covid-19 is also possible. To do so, follow all4shooters on Facebook or Instagram, link and comment on the Glock 44 post with 3 people with whom you would like to visit the shooting range and repost the image using the hashtags #myG44target and #all4shooters in your stories. The participation is only possible within the participation period.

Photos uploaded after the entry deadline will not be considered for the draw.

Only one submitted image per participant will take part in the competition. It is prohibited to use multiple Instagram or Facebook profiles to increase the chances of winning.

Participation in the competition is free of charge.

Eligible participants

The competition is open to natural persons who are resident in the EU and have reached the age of 18. Participation is not restricted to customers of the organizer and does not depend on the purchase of goods or services.

Should a participant be restricted in his/her legal capacity, the consent of his/her legal representative is required.

Not eligible to participate in the competition are all persons involved in the conception and implementation of the competition and employees of the operator as well as their family

members and employees of the company GLOCK GmbH, Deutsch-Wagram, Austria.

Furthermore, the operator reserves the right to exclude persons from participation at its own discretion if there are justified reasons, for example:

(a) in the event of manipulation in connection with access to or performance of the competition, (b) in the event of breach of these terms and conditions, (c) in the event of unfair trading, or (d) in the event of false or misleading statements in connection with participation in the competition.

Winning, Notification and Transmission of Prizes

The following prizes will be awarded:

1st prize: A GLOCK 44 pistol set consisting of a G44 pistol, 2 magazines, 1 loading aid tool, cleaning set, user manual and pistol case.

2nd prize: A GLOCK fan package (G44 T-shirt, G44 cap, G44 sports bag, targets, G44 stickers and a G44 pen)

The winners will be determined after the closing date in a random draw among all participants. The winners of the competition will be informed promptly by a separate email about the prize.

The prize will be handed over exclusively to the winner. If you want to win the main prize, you must also be in possession of a valid authorization. You must present this authorization before receiving the prize; if you do not present the authorization within a period of 2 weeks after the notification of the prize, the claim on the main prize will expire. In this case the main prize will be raffled again. Exchange, self-collection and cash payment of the prize are not possible. Any costs incurred for shipping the prizes will be borne by the operator. Any additional costs associated with the claiming of the prize will be borne by the winner. The winner is responsible for any taxation of the prize.

If the winner does not respond within a period of 2 weeks after being requested to do so twice, the prize will be raffled again.

Termination of the competition

The organizer expressly reserves the right to terminate the competition without prior notice and without giving reasons. This applies in particular to any reasons that would disrupt or prevent the scheduled running of the competition.

Privacy policy

To participate in the competition, personal data must be provided. The participant affirms that the personal details provided by him/her, in particular first name, surname and email address are true and correct.

The organizer points out that all personal data of the participant will not be passed on to third parties without consent, nor made available for use by third parties.

In case of a win, the winner agrees to the publication of his/her name and place of residence in the advertising media used by the organizer. This includes the announcement of the winner on the operator's website and its social media platforms.

The participant can revoke his/her declared consent at any time. The revocation must be addressed in writing to the contact details of the organizer given in the imprint area. After revocation of the consent, the collected and stored personal data of the participant will be deleted immediately.
